

CHAPTER: 4 - BID QUALIFICATION CRITERIA (BQC)**1. Technical Criteria:**

- 1.1 The bidder shall have successfully completed at least one work order of complete maintenance and up-keeping of an Operational Cross-Country Hydrocarbon pipeline/ CGD (Steel Pipeline Network); which should include Maintenance, Replacement & execution work of Civil, Mechanical, Electrical and Instrumentation work for minimum 200 Kms in a single work order during last 7 (Seven) years reckoned from the bid submission date.
- 1.2 The bidder shall have successfully completed at least one or more similar work as per clause 1.1 above, during last seven (7) years reckoned from the date of bid submission of value not less than INR 1 Crores excluding taxes.

2. Financial Criteria

- 2.1 The Bidder shall have minimum annual turnover not less than INR 2.0 Crores for each of the last three (3) financial years i.e. FY 2024-25, FY 2023-24 and FY 2022-23.
- 2.2 Net Worth: Bidder shall have positive net worth as per audited accounts as on 31-03-2025. Net Worth shall be Paid up share capital plus Free Reserves & Surplus less accumulated losses, deferred expenditure and miscellaneous expenditure not written off, if any. CA certificate with UDIN number and Annual Reports shall be submitted to this effect.

3. OTHER REQUIREMENTS:

- 3.1 Bidder shall be a Company registered under Companies Act 1956/2013.
- 3.2 Consortium / Joint Venture bids are not acceptable. Experience as a member of consortium /Joint Venture will not be considered.
- 3.3 Bidder shall have a valid ISO Certificate for Quality Management System (QMS) i.e. ISO 9001-2015.
- 3.4 The Bidder is not put on "Holiday" by GIGL/ GTL or any of its Group Company or Public Sector Project Management Consultant (like EIL, Mecon) or banned/blacklisted by Government department/public Sector Undertaking on due date of submission of bid. Further, neither Bidder nor their allied agency/(ies) are on banning list of the GIGL/GTL or any of its Group Company or Ministry of Petroleum and Natural Gas.

In case there is any change in status of the declaration prior to award of contract, the same has to be promptly informed to the Owner by the Bidder

It shall be the sole responsibility of the Bidder to inform about their status regarding “Holiday/Banned/Blacklisted” on due date of submission of bid and during the course of finalization of the tender. Concealment of the facts shall tantamount to misrepresentation of facts and shall lead to action against such Bidders as per provision of tender.

The Bidder shall be required to furnish an undertaking in respect of the above, on Non-Judicial stamp paper of appropriate value, in a format prescribed in tender, as part of its bid submission

- 3.5 Bidder shall not be under insolvency, liquidation, court receivership or similar proceedings. Bidder shall submit self-declaration certificate in this regard.
- 3.6 Bidders who have initiated legal action/litigation against GIGL or GTL or any of its group company, shall not be considered eligible for bidding. Further, Bidders against whom GIGL or GTL or any of its group company has initiated inquiry/ legal action/ litigation shall not be considered eligible for bidding. Bidder shall submit self-declaration certificate in this regard.

NOTES:

1. Experience of only the bidding entity shall be considered. In-house work experience shall not be considered as valid experience for the purpose of qualification.
2. Bidder to submit all relevant documentary evidence establishing compliance towards aforementioned bid qualification criteria failing which it shall render the bid to be summarily rejected at sole discretion of Owner.
 - Bidder to submit Copy (ies) of complete Purchase Order.
 - The bidder must submit work order(s), performance cum completion certificates stating the contract value as a proof of similar work done with any company/organization. Work executed as a sub-contractor will not be considered.
 - In case the bidder is executing a contract, which is still running and the contract period executed as on tender submission date is equal to or more than the minimum one year meeting stated requirements as mentioned in the BQC, such experience will also be taken in to consideration provided that the bidder shall submit satisfactory Work Execution Certificate (clearly specifying the executed period/ duration) to this effect issued by the end User/Owner.
 - The executed work shall indicate the total value of completed job, inclusive of Service Tax/GST.
