## Bid Qualification Criteria

### 1. Technical Criteria

- 1.1 The Bidder shall have designed, tested, supplied and commissioned minimum One (01) skid of Turbine Meter having minimum 3” size and 600# or higher pressure rating (the inlet class rating of skid shall define the class rating) for natural gas application with compliance to AGA 7 or equivalent ISO standard (in minimum combination of Metering and Pressure Reduction Components OR Metering and Filtration Components) in the last Ten (10) years reckoned from date of NIT.
- 1.2 Bidder shall have valid ISO 9001: 2015 Quality Management System certification

### 2. Financial Criteria

- 2.1 Bidder shall have positive net worth as per audited accounts as on 31-03-2025. Net Worth shall be Paid up share capital plus Free Reserves & Surplus less accumulated losses, deferred expenditure and miscellaneous expenditure not written off, if any. CA certificate with UDIN number and Annual Reports shall be submitted to this effect.
- 2.2 Bidder has to submit valid PAN and valid GST Registration certificate

### 3. Other Criteria

- 3.1 Bidder shall be a Company registered under Companies Act 1956/2013 or under Limited Liability Partnership Act, 2008.
- 3.2 The Bidder is not put on “Holiday” by GIGL/ GTL or any of its Group Company/ Public Sector Project Management Consultant (like EIL, Mecon) or banned/blacklisted by Government department/public Sector Undertaking on due date of submission of bid. Further, neither Bidder nor their allied agency/(ies) are on banning list of GIGL/ GTL or any of its Group Company/ the Ministry of Petroleum and Natural Gas.

In case there is any change in status of the declaration prior to award of contract, the same has to be promptly informed to the Owner by the Bidder.

It shall be the sole responsibility of the Bidder to inform about their status regarding “Holiday/Banned/Blacklisted” on due date of submission of bid and during the course of finalization of the tender. Concealment of the facts shall tantamount to misrepresentation of facts and shall lead to action against such Bidders as per provision of tender.

The Bidder shall be required to furnish an undertaking in respect of the above, on Non Judicial stamp paper of appropriate value, in a format prescribed in tender, as part of its bid submission.

Bidder to submit self-declaration on stamp paper of appropriate value for above Requirement

- 3.3 The Bidder shall be not be under insolvency, liquidation, court receivership or other similar legal proceedings. Bidder shall submit self-declaration certificate in this regard.

4. Consortium / Joint Venture bids are not acceptable. Experience as a member of consortium /Joint Venture shall not be considered.

1. Bidder to submit all relevant documentary evidence establishing compliance towards aforementioned bid qualification criteria in totality failing which it shall render the bid to be summarily rejected at the sole discretion of Owner.
